What is this product?

Type: This product is a sub-fund of Elevation Fund SICAV, an open ended investment company with variable capital and an umbrella fund with segregated liability between the sub-funds, established under the laws of Luxembourg and authorised by Commission de Surveillance du Secteur Financier as a UCITS for the purposes of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment, as may be amended from time to time.

Intended Retail Investor: Suitable for investors with a medium to long-term time horizon, typically five years or more.

Term: The Fund has no maturity date.

Objectives:

The Fund objective is to provide long-term (in excess of 5 years) capital growth.

In order to achieve this objective, Fund will invest primarily in the shares of companies that are domiciled in, based in or carry out the larger part of their business activities in Europe and are listed on a regulated market. The Fund integrates selected social and/or environmental factors in its investment process to achieve responsible investment characteristics, such as climate change mitigation, over the long term. The Fund may invest a minimum of 50% of its net assets in portfolio companies that promote such characteristics. The Fund may also invest, directly or indirectly, in non-European companies that are listed on a regulated market. Indirect exposure will be via eligible UCIs. The Fund may invest up to 10% of its net assets in units or shares of UCITS and/or other Eligible UCIs. On an ancillary basis, the Fund may also hold liquidities such as, among others, cash deposits, money market Funds and Money Market Instruments. The Fund may use financial derivative instruments for hedging. The financial derivative instruments the Fund is permitted to use are limited to futures and options listed on a regulated market. The Fund will have a portfolio of approximately 40-50 holdings. The investment manager seeks to invest in companies that in their opinion are undervalued but have strong potential to increase in value through margin expansion and/or earnings growth. In accordance with article 8 of EU Regulation 2019/2088, the Sub-Fund promotes environmental or social characteristics, as further described in the Prospectus.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less than your original investment.

If the Fund currency differs from your investment currency, you will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level. Poor market conditions could impact your returns.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The figures shown include all the costs of the product itself, but do not take into account your personal tax situation and may not include all the costs that you pay to your advisor or distributor, which may also affect how much you get back.

The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable, moderate, and favourable scenarios shown are illustrations of what you might get back using the worst, average, and best performance of the product / a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

What happens if the Company is unable to pay out?

The assets of the Fund are entrusted to the Depositary. If the Fund encounters financial difficulties, the assets entrusted to the Depositary (or its delegates) will not be affected. If the Depositary (or its delegates) encounter financial difficulties, the Fund could suffer a loss in some circumstances.

What are the costs?

Costs over Time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for two different holding periods. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future. The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs and show you the impact that all costs will have on your investment over time.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs. The amounts shown here are illustrations based on an example investment amount and different possible investment periods:

We have assumed that you invest EUR 10,000 and that in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
